

This document contains the guidance and scoring used by the Assessors when reviewing your application. Assessors will review your answers for each scored question and mark each of them between 0 and 25 (0 being the lowest and 25 being the highest).

Any questions that are not scored will not be reviewed by the Assessor.

### **Question 1. Applicant location (not scored)**

You must state the name and full registered address of your organisation and any subcontractors. If the work location for your project is different to your registered address then you must state the work location for your project.

We are collecting this information to understand the geographical location of all applicants. Your answer to this question will assist us to assess your eligibility in this competition.

### **Question 2. Minimal Financial Assistance declaration (not scored)**

You must download the declaration template. You must complete this, declaring any funding received under Minimal Financial Assistance (previously referred to as Special Drawing Rights) or De minimis awards, (from any source of public funding) in the applicable period.

You must complete all the fields on your form before uploading.

You must write “declaration attached” in the question text box.

You must upload the completed declaration as an appendix. It must be a PDF and the font must be legible at 100% zoom.

You must keep all documentation relating to Minimal Financial Assistance (previously referred to as Special Drawing Rights) and other De minimis awards for a period of 6 years and be prepared to release it to any public funding body which requests it.

How will you fund the 30% of your project costs that are not being paid in advance?

You must include:

- your funding strategy and how you will continue to support the development of the innovation following completion of the project, with a view towards its eventual commercialisation

### **Question 7. The idea**

What is the problem you wish to solve and why is your proposed approach a good and innovative solution?

You must consider the following in your answer:

- the specific innovation you propose to develop and how this is different and better than alternative solutions
- the specific need and size of opportunity
- why your solution is affordable and investable
- any barriers to adoption and how they could be overcome

**Question 7. Assessor guidance and scoring:**

Scores 21 - 25

In your opinion, the applicant makes a compelling case for the innovation, and clearly and convincingly describes:

- how the idea is innovative and why it is different and better than alternatives
- and understands both the market need and size of opportunity with evidence
- how the idea is both affordable in the target market, and why it would make a good commercial investment for scale up
- and understands all the barriers to adoption and how they can be overcome

Scores 16 - 20

In your opinion, the applicant makes a justified argument for the innovation. The response is not totally clear or convincing in some areas, but adequately describes:

- how the idea is innovative and why it is different and better than alternatives
- and understands the market need and the size of opportunity
- how the idea is both affordable in the target market and makes a good commercial investment for scale up
- and understands all the barriers to adoption and how they may be overcome

Scores 11 - 15

In your opinion, the applicant makes a case for the innovation but falls short in a number of areas and does not adequately describe:

- how the idea is innovative, or why it is different and better than alternatives
- and understand the market need and size of opportunity, and is not convincing or evidenced
- describe how the idea is affordable and investible
- or understand many of the barriers to adoption

Scores 6- 10

In your opinion, there are significant gaps in the applicant's argument for the innovation, which is poor and does not describe:

- how the idea is innovative or why it is different and better than alternatives
- and understand the market need or opportunity
- describe why the idea is affordable or investible
- or understand the barriers to adoption

Scores 0 - 5

In your opinion, the answer is lacking and inadequate in all areas

### **Question 8. Impact and added value**

What will be the impact of receiving the grant to your business?

You must consider the following in your answer:

- why public funding is necessary and value for money, for example, is there currently a lack of investment, or market failure
- the impact on your business

- the tangible outputs of the project in terms of specific deliverables and how the UK will benefit
- what are the expected impacts on society, the economy and the environment

Note: projects that purely result in reports, academic papers or similar, are not considered to be tangible impact in line with the aims of this competition

### **Question 8. Assessor guidance and scoring:**

Scores 21 - 25

In your opinion, the applicant makes a compelling case for the positive impact public funding for the project will make. The response is strong, and clearly and convincingly describes:

- why public funding is required for the business to develop the idea
- the impact on the business
- the outputs of the project in terms of specific deliverables and how the UK will benefit

Scores 16 - 20

- the outputs of the project in terms of specific deliverables and how the UK will benefit
- identify and understand the expected impacts on society, the economy and the environment
- or, the output is simply a report or similar

### **Question 9. Business resources and capabilities**

Explain why your business is capable of delivering this project.

You must consider the following in your answer:

- what resources you can access, including the main people involved, relevant track records, and any external resources
- your capability to deliver in the required timeframe given your existing business activities or constraints
- how you will deliver outcomes and impact beyond the life of the project, what is your route to market
- how equality, diversity and inclusion (EDI) is incorporated into your proposed project or business activities, for example, in the development of your innovation, accessibility of project results, team composition, work environment

### **Question 9. Assessor guidance and scoring:**

Scores 21 - 25

In your opinion, the applicant is well placed to deliver and exploit the project. The response is strong, and clearly and convincingly describes:

- the resources the business can access, including the main people involved, relevant track records, and any external resources
- the capability to deliver in the required timeframe in the context of existing business activities or constraints
- how the business will deliver outcomes and impact beyond the life of the project, and the route to market
- how the business will promote equality, diversity and inclusion (EDI) as a business

Scores 16 - 20



In your opinion, the applicant appears well placed to deliver and exploit the project. The response is not totally clear or convincing in some areas, but adequately describes:

- how the business will deliver outcomes and impact beyond the life of the project, and the route to market
- how the business will promote equality, diversity and inclusion (EDI) as a business

#### Scores 6 – 10

In your opinion, the response to this question has serious deficiencies and missing aspects and does not describe:

- the resources the business can access, including the main people involved, relevant track records, and any external resources
- the capability to deliver in the required timeframe in the context of existing business activities or constraints
- how the business will deliver outcomes and impact beyond the life of the project, and the route to market
- how the business will promote equality, diversity and inclusion (EDI) as a business

Scores 0 – 5

In your opinion the applicant will not be capable of either carrying out the project or exploiting the results.

### **Question 10. Work packages and costs**

You must consider the following in your answer:

- what the funding will be spent on, referring to costs for main work packages
- project risks and how you will mitigate them
- your freedom to operate for example, patents, intellectual property IP
