Why are we supporting innovation?

Productivity: The UK has seen lower productivity growth than our neighbours over the last 30 years

Environment: Agriculture accounted for 10% of UK greenhouse gas emissions in 2018

Fragmentation: many fantastic researchers, innovative businesses and promising ideas, but players don't necessarily collaborate effectively

Coordination: failures in the current innovation system result in poor translation of public spending into real life impacts on productivity/sustainability

Adoption: Low levels of uptake of innovation by farmers, growers, businesses in large part due to capital risk & ineffective knowledge sharing

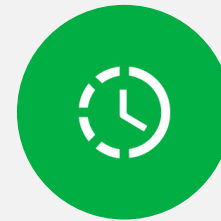

Accelerating Development of Practices and Technologies Fund

- Two grants - the **Facilitator Support Grant** and the **ADOPT Full Grant**, these are designed to make ADOPT funding accessible to a wider range of applicants.
- ADOPT Support Hub and IUK Business Connect Project Facilitator database to provide practical and expert advice to participants.
- ADOPT is focussed on collaborative, smaller-scale, farmer-led projects to address immediate on-farm productivity and sustainability challenges.
- Projects will trial, test and demonstrate the on-farm viability of new and existing technologies, processes and practices for the benefit of the sector.
- Successful projects will last up to 2 years and have total project costs between £50K-£100K.

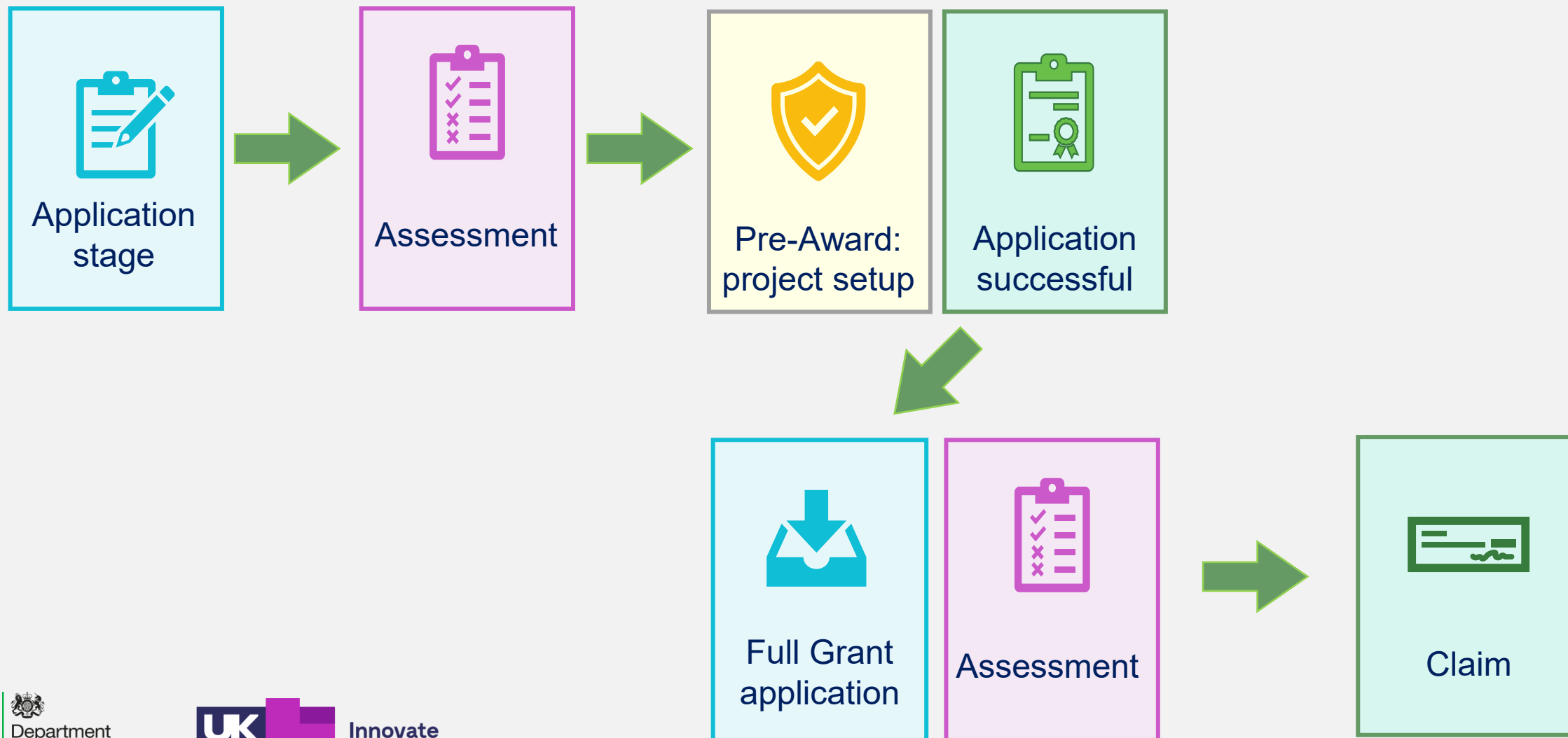

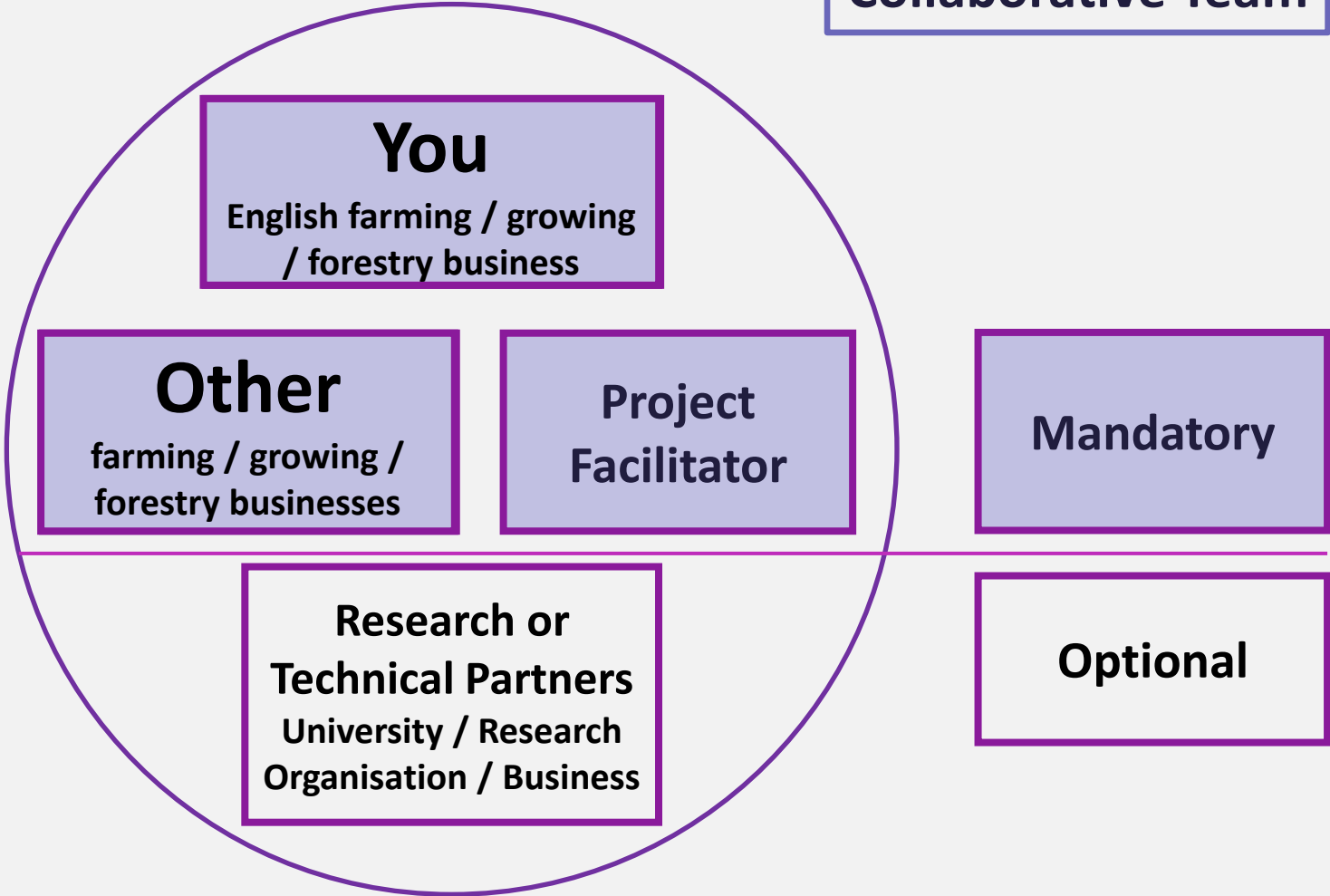

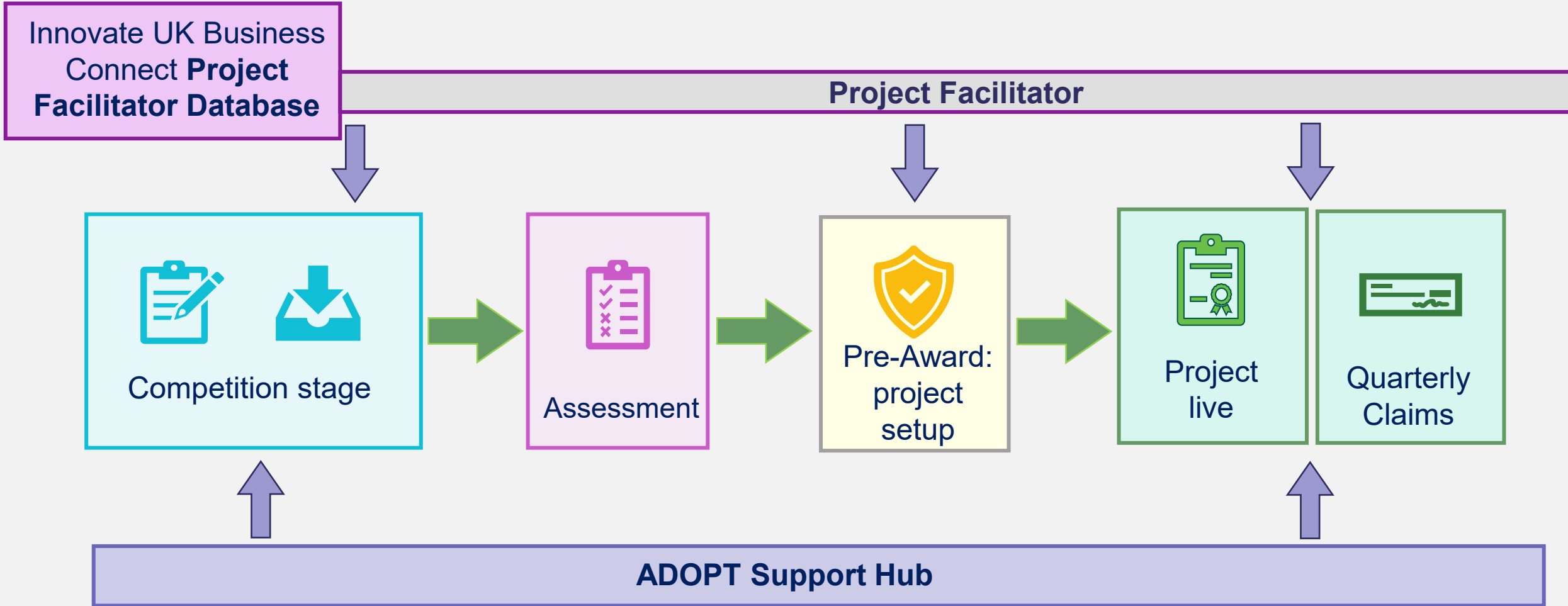

Address major on-farm or immediate post farmgate challenges or opportunities. Solutions being trialled **must significantly improve:**

- ✓ productivity
- ✓ resilience
- ✓ sustainability and progression towards net zero emissions





Scope



Exclusions, we are not funding projects that:

- × do not benefit farmers, growers or foresters in England
- × are based on funded crop variety plot trials
- × are based on existing demonstration trials or projects
- × are for the production of crops or plants for medicinal or pharmaceutical use
- × are for cultivated meat
- × are based on equine systems
- × involve wild caught fisheries
- × involve aquaculture, such as algae and seaweed, fermentation systems for bacteria, yeast or fungi for human consumption

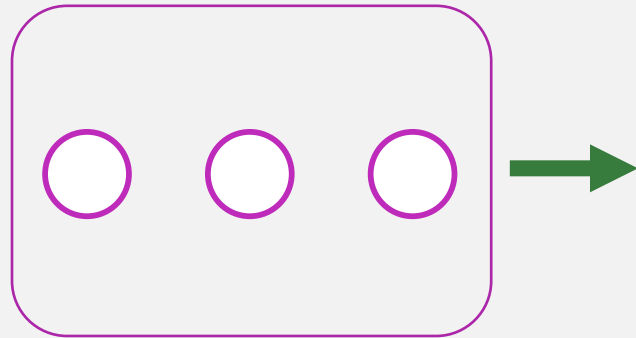

Farmers only:

- Farmers are able to calculate their trial expenses based upon labour day/ hourly rate or rate x Hectare
- All applicable costs can be rolled in to one single cost and entered in “Other Costs” category which is validated during the set-up stage and will be accepted at claims stage.
- i.e. use of tractor to cultivate a field, time for a farmer to operate the tractor, operating costs such as fuel and maintenance, cost of using other machinery, fertilisers, seed etc
- It's possible to claim professional memberships relevant to the project.

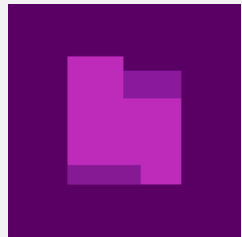

Eligibility Criteria – Your Project –ADOPT Facilitator Support Grant: Round 6

Your project must:

To be eligible to apply for this competition, you must:

- engage with an external Project Facilitator that is registered in the [Innovate UK Business Connect database](#)
- work with the facilitator to develop and submit an eligible application for a Full ADOPT Grant competition

If you are successful in this competition you will need to provide evidence within six months of the funding being awarded that your Full ADOPT Grant application has been sent for assessment.

A total of £2,500 will be awarded per successful participant once the claim and evidence is submitted.

Eligibility Criteria – Lead Organisation – ADOPT Facilitator Support Grant: Round 6

Lead organisation:

To lead a project your organisation must:

- be an active farming, growing or forestry [business](#) of any size based in England
- be able to evidence that you are an established commercial business, including sole traders and partnerships
- have a UK bank account

Eligibility Criteria – Partners/Subcontractors – ADOPT Facilitator Support Grant: Round 6

Subcontractors

Subcontractors are not allowed in this competition.

Project Facilitator

The Project Facilitator is the person who will be working with you to submit a Full ADOPT Grant application. They must be registered in the Innovate UK Business Connect database.

You must only include in the 'other costs' line of the finance section the name of the Project Facilitator you will be working with and the maximum grant amount of £2,500.

Eligibility Criteria – Number of applications – ADOPT Facilitator Support Grant: Round 6

Number of applications

A farmer, grower or forester can only lead on one application per competition round and receive a maximum of two Facilitator Support Grants in total.

Eligibility Criteria – Your Project – ADOPT Full Grant: Round 6

Your project must:

- have total costs between £50,000 and £100,000
- last between 6 and 24 months
- intend to exploit the results from or in England
- carry out all of its project work in the UK
- embrace open innovation principles and be willing to share results with other farmers, growers or foresters
- have a Project Facilitator as part of the project team who is listed in the ADOPT [Innovate UK Business Connect database](#)

Eligibility Criteria – Lead Organisation – ADOPT Full Grant: Round 5

Lead organisation:

To lead a project your organisation must:

- be an active farming, growing or forestry business of any size **based in England**
- be able to evidence that you are an established commercial business, including sole traders and partnerships
- have a UK bank account
- collaborate with at least one other farming or growing businesses of any size, based in the UK

It is desirable that you also collaborate with other UK registered organisations.

More information on the different types of organisation can be found in our Funding rules.

Eligibility Criteria – Collaboration – ADOPT Full Grant: Round 6

For this competition your project must be collaborative.

In all collaborative projects there must be:

- at least two grant claiming partners
- evidence of an effective collaboration

This means one partner must not account for more than 70% of the eligible costs and you must include rationale for the collaboration and describe the structure in the application.

Eligibility Criteria – Project Team – ADOPT Full Grant: Round 6

Project team

To collaborate with the lead, your organisation must be a farmer, grower or forester based in the UK .

You may also collaborate if you are a UK registered:

- business of any size
- academic institution
- charity
- not for profit
- public sector organisation
- research organisations
- research and technology organisation (RTO)

Eligibility Criteria – Partners/Subcontractors – ADOPT Full Grant: Round 6

Subcontractors

Subcontractors are allowed in this competition.

Subcontractors can be from anywhere in the UK and you must select them through your usual procurement process.

You can use subcontractors from overseas but must make the case in your application as to why you cannot use subcontractors from the UK.

You must provide a detailed rationale, evidence of the potential UK contractors you approached and the reasons why they were unable to work with you. We will not accept a cheaper cost as a sufficient reason to use an overseas subcontractor.

All subcontractor costs must be justified and appropriate to the total project costs.

Eligibility Criteria – Number of applications – ADOPT Full Grant: Round 6

Number of applications

A farmer, grower or forester can only lead on one application but can be included as a collaborator in two further two applications.

If an organisation is not leading an application, it can collaborate in any number of applications

Previously submitted applications

Pros & Cons of using AI to support you

With the advances in AI technology, it is only natural to use technology to support you in applying to our competitions. Whilst we don't recommend or advise against it, we would like to make you aware of the following which could potentially impact your project.

Pros

- Removes barriers for people with disabilities and non-English speakers
- Allows you to rephrase your content to meet the word count in a question
- Ensures all aspects of a question are answered
- Can aid a better understanding of:
 - intended/wider market
 - best practice in project management
 - complementary technologies and advances in the industry
 - expected project impacts

Cons

- It is not always accurate in its assumptions and can get things wrong
- AI learns from the information you give it as well as what it has already learnt
- May provide a generic response meaning your application could use similar phrasing to others
- AI can be detected as non-human as it lacks expression and insight because it relies on logic to summarise information based on the question asked

Whilst AI offers many benefits, it is important you are aware that **you are potentially sharing your idea with the world**, so be careful what you share as you have no control over how it is shared on once you do.

Funding Rules



Other Innovate UK projects

If you have an outstanding final claim or Independent Accountant Report (IAR) on a live Innovate UK project, you will not be eligible to apply to this competition, as a lead or a partner organisation.

We will not award you any further funding if you:

- applied to a previous competition as the lead or sole company and were awarded funding by Innovate UK, but did not make a substantial effort to exploit that award
- applied to a previous competition as the lead or sole company and failed to comply with grant terms and conditions.

Compliance with the UK Subsidy Control Regime

On 4th January 2023, the [Subsidy Control Act 2022](#) came into effect.

This provides a framework for public authorities to design and award subsidies in a compliant way, whilst minimising any negative effects of subsidies both within the UK and Internationally.

Innovate UK offers funding in line with the UK's obligations and commitments to Subsidy Control. To ensure that Innovate UK remains compliant with the UK's international Subsidy Control duties in respect of:

- the EU-UK Trade and Cooperation Agreement;
- the subsidy control act 2022
- Article 10 of the Windsor Framework (successful applicants which are affected by the Windsor Framework will be funded in line with [EU State aid regulations](#))
- Article 138 of the Withdrawal Agreement (some Union law applicable after 31 December 2020 in relation to the UK's participation in Union programmes and activities)
- the Subsidies and Countervailing measures within the WTO (ASCM)
- any other Free Trade Agreements active at the time of award

All awards will be conditional on compliance at all times with the UK's international obligations on Subsidy Control - this will be reflected in the terms and conditions of any award.

Subsidy Control (and State aid where relevant)

The Subsidy Control Act 2022 definition of a 'subsidy' means financial assistance which:

1. is given by a public authority. This can be at any level: central, devolved, regional or local government or a public body.
2. makes a contribution (this could be a financial or an in-kind contribution) to an enterprise, conferring an economic advantage that is not available on market terms.
3. affects international trade.

For awards made from 4 January 2023, the majority are subject to Subsidy Control Act 2022. EU State aid rules now only apply in certain limited circumstances.

Financial viability and eligibility

Innovate UK is unable to award funding to organisations that are considered to be in financial difficulty. All applicant organisations are subjected to financial viability and eligibility checks to ensure they are suitable for public funding.

Article 10 of the Windsor Framework

The EU and the UK formally adopted the [Windsor Framework](#) on 24 March 2023.

The Windsor Framework replaces the Northern Ireland Protocol, providing a new legal and UK constitutional framework.

Article 10 provides that European Union State aid rules will continue to apply to the UK in respect of measures which affect trade in goods or the electricity market between Northern Ireland and the EU.

Article 10 does not directly apply to subsidies for services and such subsidies will need to comply with the UK's subsidy control regime.

Undertakings in difficulty

In the unusual circumstance of an award having to be made under the EU GBER regulation (State aid), the applicant must pass **'undertaking in difficulty' checks as defined by GBER (2014)**.

Project setup

If you pass the technical assessment, you will have a further eight steps detailed in your notification to complete in Project Setup before being able to start your project.

These are:

- Project details
- Project team
- Documents
- You will be allocated a Monitoring Service Provider (MSP)
- Bank details
- Finance checks
- Spend profile
- Grant Offer Letter

Please share the T&Cs with your legal team at the earliest possible opportunity to avoid any delays.

For the Support Grant you are expected to complete all the steps above within 40 calendar days of receiving your notification.

You are expected to complete all the steps above within 90 calendar days of receiving your notification. Failure to do so may result in funding being withdrawn.

Work can only commence on your project once you have received your Go Live email.
